

**NOTICE OF PROPOSED AMENDMENTS OF THE NAMIBIAN CIVIL AVIATION REGULATIONS,
2001 (AS AMENDED): PART 187 (FEES and CHARGES): CIVIL AVIATION ACT, 2016**

1. The Namibia Civil Aviation Authority in terms of Regulation 3.04.3 regarding Regulations Making, publishes this notice to amendment of Part 187 (Fees and Charges).
2. Part 187 of the regulations was last amended in 2017 and 2018, respectively.
3. (a) The purpose of the proposed amendment is to increase existing fees and charges based on inflation so as to be cost reflective of the services rendered by NCAA. Further, to introduce fees and charges for services rendered by NCAA but not paid for by aviation participants. An amendment on passenger safety charge from available seat per departing aircraft to occupied seat per departing aircraft.

(b) The proposed fees/charges were benchmarked with other civil aviation authorities in Africa.
4. Interested persons or groups of persons are invited to submit written comments/submissions on the proposed amendments, to Part 187 no later than 23 February 2023 from the date of publication of this Notice.

SCHEDULE

Definitions

1. In these regulations, “the Regulations” means the Namibian Civil Aviation Regulations published under Government Notice No. 1 of 2 January 2001 as amended by Government Notice No. 57 of 1 April 2006, Government Notice No. 201 of November 2006, Government Notice No. 80 of 1 April 2017, Government Notice No. 210 of 31 August 2018, Government Notice No. 410 of 30 December 2019, Government Notice No. 89 of 27 March 2020 , Government Notice No. 112 of 30 April 2020 and Government Notice No. 236 of 30 September 2020.

Amendment of regulation 1.00.1

2. **Regulation 1.00.1 of the Regulations is amended -**

“occupied seat” means the seat or space on an aircraft occupied for the purposes of passenger use in relation to international or domestic flight providing air services whether scheduled or non-scheduled”;
